RATIONALE

The significance of having a Training Needs Assessment (TNA) survey lies in its ability to provide a systematic and data-driven approach in identifying and addressing the learning requirements of employees. The City Human Resource Management Office utilized this tool for the departments seeking to optimize training investments, improve employee performance and engagement, and maintain their competitive edge in the organization. It provides a foundation for targeted and effective training initiatives that align with organizational goals, directions and contribute to long-term success.

The City Human Resource Management Office operates this system to deliver high-quality training programs that meet the identified needs of employees and to ensures resources are allocated effectively by targeting areas where they will have the most impact. In addressing skills gap, it can lead to improve job performance and employee will excel their roles and become more productive, efficient and capable meeting performance standards. Investing of employees' development through this, can also enhance retention rates and contribute to talent development within the organization and stay ahead on technological advancements.

METHODOLOGY

The CHRMO has developed an online survey form that covers required skills and knowledge, existing competencies, training preferences and perceived training needs for the Training Needs Assessment (TNA) for 2025 of LGU-SJC employees. Respondents were instructed to rate and select each topic as "Much Needed," "Needed," or "Not Needed". On April 25, 2024, a total of 693 employees from LGU-San Jose City excluding the city officials were informed via online links to participate in the online survey. Out of these, 442 regular employees responded, resulting in a response rate of 63.78 %, which falls within the recommended response rate by research experts.

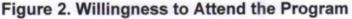
This marks the 2nd utilization of the online form to assess employees' needs for career development, serving as a more streamlined and safer tool for the City Government of San Jose to identify the specific types of training that should be prioritized by its Human Resource Management Office.

RESULTS:

Figure 1 shows the gender distribution among the four hundred forty-two (442) respondents: with 189 respondents (42.8%) being male, 248 respondents (56.1%) being female, and 7 respondents (1.6%) identifying as LGBTQ+. Moreover, out of the total respondents, four hundred thirty-nine (439) individuals (99.3%) expressed their willingness to attend the training/seminar, while three (3) respondents (0.7%) indicated their lack of interest (See Figure 2).

Figure 1. Gender



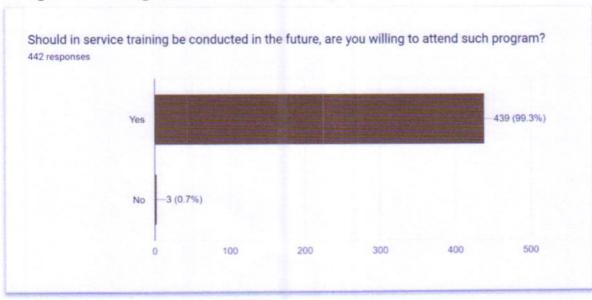
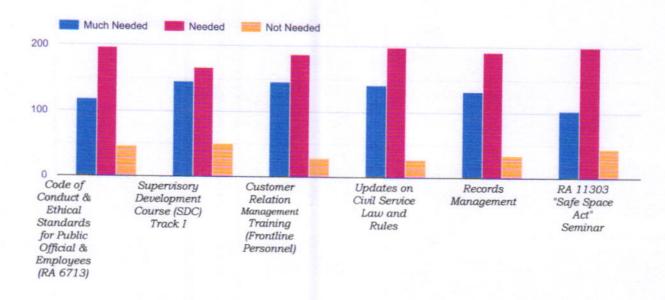


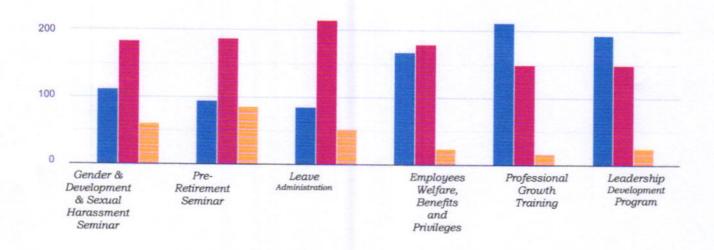

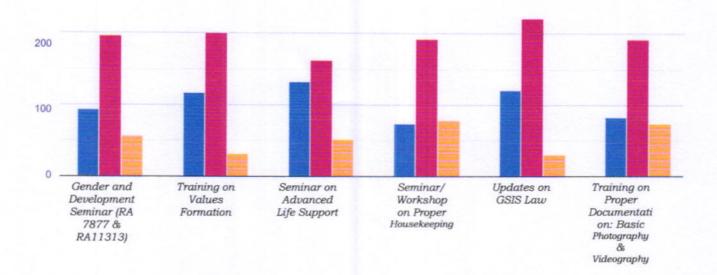

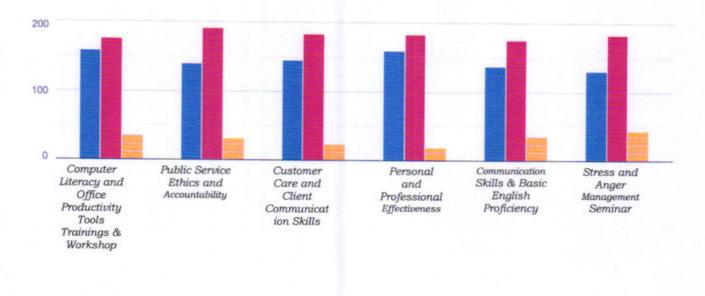
Figure 3. Online Survey Result

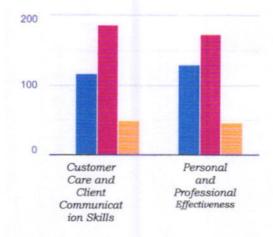

FINDINGS:

The online survey for training needs assessment revealed through analyzing the responses, regarding areas where employees feel they require further training and support. These include supervisory skills, technical skills, communication skills, and leadership development. Respondents expressed a need for training programs to their specific roles and responsibilities within the organization and survey highlighted the importance of providing opportunities for continuous learning and development to enhance job performance and career growth.

Based on the survey result, the top five (5) trainings that highly recommend topics falling under the "Much Needed" rating category, are as follows: Updates on Civil Service Law and Rules (85.30%), Code of Conduct & Ethical Standards for Public Official & Employees (RA 6713) (76.69%), Professional Growth Training (47.96%), Leadership Development Program (44.34%), Employees Welfare, Benefits and Privileges (43.44%), Supervisory Development Course (SDC) Track I (42.76%), Customer Relation Management Training (Frontline Personnel) (40.72%), Personal and Professional Effectiveness (40.27%), Records Management and Computer Literacy (39.59%) and Office Productivity Tools Trainings & Workshop (38.01%).

The next top five (5) are Supervisory Development Course (SDC) Track I, Customer Relation Management Training (Frontline Personnel), Personal and Professional Effectiveness, Records Management and Computer Literacy and Office Productivity Tools Trainings & Workshop.

RECOMMENDATION:

Several training topics have been identified recommend for continual learning and development for government employees. These include Updates on Civil Service Law and Rules, Code of Conduct & Ethical Standards for Public Official & Employees (RA 6713), Professional Growth Training, Leadership Development Program, Employees Welfare, Benefits and Privileges, Supervisory Development Course (SDC) Track I, Customer Relation Management Training (Frontline Personnel), Personal and Professional Effectiveness, Records Management and Computer Literacy and Office Productivity Tools Trainings & Workshop, Supervisory Development Course (SDC) Track I, Customer Relation Management Training (Frontline Personnel), Personal and Professional Effectiveness, Records Management and Computer Literacy and Office Productivity Tools Trainings & Workshop. All these were rated on "Much Needed" and "Needed" on Table 5.

We highly recommend prioritizing the mentioned topics for our training efforts. It is proposed that adequate funds be allocated for conducting the identified trainings during the fiscal year 2025. By investing in these training programs, we aim to equip our employees with the knowledge and skills they have identified as crucial. This initiative is seen as critical in promoting and assisting our employees in delivering enhanced service to the City Government of San Jose and its constituents.

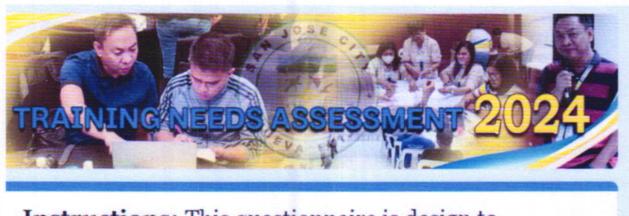
